## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14(1)**

## THE WARWICKSHIRE COUNTY COUNCIL (D5021 NUTHURST ROAD, A3400 LIVERIDGE HILL & A3400 BIRMINGHAM ROAD, HENLEY IN ARDEN) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2020

<u>WHEREAS</u> the Warwickshire County Council ("the Council") as traffic authority for D5021 Nuthurst Road, A3400 Liveridge Hill & A3400 Birmingham Road, Henley in Arden is satisfied that traffic on the said roads should be restricted by virtue of works proposed to be executed thereon.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:

- 1. This order shall come into operation on 19 January 2020 and may be cited as "The Warwickshire County Council (D5021 Nuthurst Road, A3400 Liveridge Hill & A3400 Birmingham Road, Henley in Arden) (Temporary Prohibition of Traffic) Order 2020".
- No person shall cause or permit any vehicle other than an exempted vehicle to use D5021 Nuthurst Road, Henley in Arden at its junction with A3400 Liveridge Hill for a period of 18 months commencing on 19 January 2020, or until the said works are completed, whichever is the earlier.
- 3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
- 4. Whilst the provisions of Article 2 are in operation no person shall drive any motor vehicle at a speed exceeding 10 miles per hour through the convoy working area on A3400 Liveridge Hill and A3400 Birmingham Road, Henley in Arden as indicated by signage for a period of 18 months commencing on 19 January 2020, or until the aforesaid works are completed, whichever is the earlier.
- 5. The provisions of Article 2 and Article 4 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.
- 6. No speed limit imposed by this order applies to vehicles falling with regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
