17.07.2017	13 To agree a date for the Neighbourhood Development Plan and Microshade Presentations – 4th or 11th September 2017 (please bring your diaries) • The Clerk advised that she would like to organise the Presentations for 11th September and asked which Cllrs would be present. All Cllrs present apart from Cllr Jackson agreed that they could be present on that date at the moment.	
18.09.2017	12 To approve the adoption of the draft Neighbourhood Development Plan and thank the Steering Group for all their hard work. • Cllr Leech reported that members had attended a presentation on the draft NDP recently and Cllrs had made several observations. It was RESOLVED that the contents of the draft NDP had been noted by members of the JPC. The Clerk was requested to contact the Steering Group to request that members' observations were incorporated in the draft Report, including the thanks of the JPC for all of the hard work that had been undertaken by the Steering Group. This motion was proposed by Cllr Crathorne, seconded by Cllr Bridges and carried by the majority. Cllr Garner abstained as he is a member of the Steering Group

11 To receive a Report updating the council on the progress of the NDP. The Clerk said that she had received a report from David Jackson. the Chair of the NDP Steering Group and she read out the email, as follows: Following the Town meeting earlier in the summer, the NDP Steering Group recently completed the post meeting consultation phase. Beaudesert and Henley-in-Arden Joint Parish Council Minutes Page 6 Having considered comments received from the public, the Steering Group met recently and agreed a further set of amendments to the NDP which have now been incorporated into the document and are with the graphic designer for inclusion in the draft NDP. Once the updated document has been received back from the Graphic Designer, the document will be sent to SDC for review and their comments. The NDP Steering Group hopes to have comments back from SDC before Christmas. Given the impending elections next year, we should aim to hold the referendum for the NDP at the same time as the elections to save costs. • Following a discussion, it was agreed that the Clerk contact the Chair of the NDP Steering Group and request that they consider improving the timing suggested and to seek clarity on the timeline prior to completion of the document. It was also agreed that the Clerk request further details in respect of the independent examiner and the length of time it would take them to complete the process. It was RESOLVED that the Clerk contact David Jackson in respect of the above matters. This motion was proposed by Cllr Cornford, seconded by Cllr Broadbent and carried unanimously.

This motion was proposed by Cllr Tomlinson, seconded by Cllr Jackson and carried unanimously.	
21.01.2019	14. To note progress of the NDP & to ratify submission of the NDP & Evidence Based	

Reports etc., to go to the Regulation 14 Consultation • The Clerk said that she had circulated a Report detailing the procedures to go to Regulation 14 to all the JPC Cllrs, together with the Chair of the NDP Steering Group and which is attached to these minutes as an Appendix. • The Clerk advised that she had met with the Chair of the NDP Steering Group and had gone through the process to go to Regulation 14 with him. She went on to say that the NDP and all the supporting documents would need to be sent out to local PCs and Cllrs, together with a generic list of consultees. The Clerk went on to say that she was liaising with the PA for the Chair of the NDP Steering Group over the logistics for the process. • The Clerk advised that once she had received consultation responses back and the NDP had taken them into consideration, the JPC would need to look at employing a Planning Consultant to carry out some of the work on the NDP in the future. • Following a brief discussion, it was RESOLVED that Regulation 14 be commenced and this motion was proposed by Cllr Garner, seconded by Cllr Field and carried unanimously.

18.02.2019	13 To note progress of the NDP • The Clerk reported that she had initiated the Regulation 14 Consultation and had sent all the documents to the statutory consultees and an advert placed in the local press. She went on to say that she had received several responses so far, together with the SEA and HRA Screening document which she had circulated to all the members of the JPC and the NDP Steering Group. She confirmed that Lepus Consulting had advised that no further SEA work is required on the draft NDP. • The Clerk advised that once the consultation period ended, she would arrange a meeting with some of the members of the Steering Group and go through	
18.03.2019	17 To note progress of the NDP • The Clerk reported that she had received several responses to the Regulation 14 Consultation, including one from SDC which said that there did not seem to be any maps included marking areas which should be protected. She went on to say she had met with members of the NDP Steering Group and Cllr Leech to see whether this issue could be resolved. SDC had also advised that they would be making additional comments in April. Once they had been received, the Clerk confirmed that she would meet with members of the WP again to incorporate any changes that were necessary.

She went on to say that she would like approval for the above Designated Green Spaces which had been uploaded on to the screen for everyone to see. Following a discussion, it was RESOLVED that no further action be taken at the present time. This motion was proposed by Cllr Leech, seconded by Cllr Garner and carried unanimously.

To note progress of the NDP The Clerk reported that she had been liaising with a member of the NDP Steering Group and previous Cllrs regarding various aspects of the Plan and comments that the SDC Cabinet had made in respect of the Regulation 14 Consultation. The Clerk had been advised that there would be an NDP Steering Group meeting on 20th May.	
17.06.2019	16. To note progress of the NDP and for the JPC to extend an invitation to the current members of the NDP Steering Group to continue to advance the NDP and to ratify their Terms of Reference • The Clerk reported that she had attended a meeting with a representative from SDC and WRCC, together with the Chair and member of the NDP Steering Group and they had suggested that a Housing Needs Survey should be carried out, which had been approved previously. Following a discussion, it was RESOLVED that the Clerk ask the current members of the NDP Steering Group whether would like to remain and continue to advance the NDP and that he Terms of Reference that the Clerk had produced by adopted. • Cllr Evans also agreed to become a member of the NDP Steering Group alongside Cllr Broadbent. These motions were proposed by Cllr Evans, seconded by Cllr Cornford and carried unanimously	
30.09.2019	19. To note progress of the NDP – Update. The Clerk reported that she had not heard anything from the NDP Steering Group, and she would contact a member of the Group to ascertain the current situation. Following a discussion

16.03.2020	10. Beaudesert & Henley in Arden NDP - update. [DB & RR] Mr Robin Rumbles ask for the floor and reported on his visit to SDC offices to discuss progress with Louisa Slator, where clarification was sought and given. In summary small amendments were needed in the publication before a full re-consultation, he asked if members of the JPC might comment on any changes by week ending 20th next. He and Cllr Broadbent will then consult with the Clerk on distribution, publicity and town consultation moving forward to adoption in due course.
